RULES: 2009 NRA Smallbore Rifle Rules

TARGET: NRA A-17

SIGHTS: Juniors - Metallic Sights, Adults – Any Sights

CHALLENGES: A challenge fee of \$1.00 will be charged for each challenge made.

ENTRIES: Open to all competitors. Teams are not for awards. Collegiate Teams and Junior Teams encouraged.

ENTRIES LIMITED: Entries are limited to 8 competitors for each relay which is the capacity of the range.

ENTRIES CLOSE: Advanced entries are appreciated but post entries will be accepted on a first come first served basis until the start of the third relay or until range capacity is filled. Entries for later relays can be reserved by pre-entry.

SIGHTING SHOTS: Unlimited sighting shots will be allowed in all matches and must be taken within the time limit.

CLASSIFICATIONS: Classifications will not be used.

CATEGORY: Categories are Junior, Not Junior.

SQUADDING: Will be assigned by the Statistical Office.

COURSE OF FIRE: NRA 4 position conventional half-match. Juniors may elect to compete in an 80 shot prone match, or the 4 position match, but not both.

Match 3:

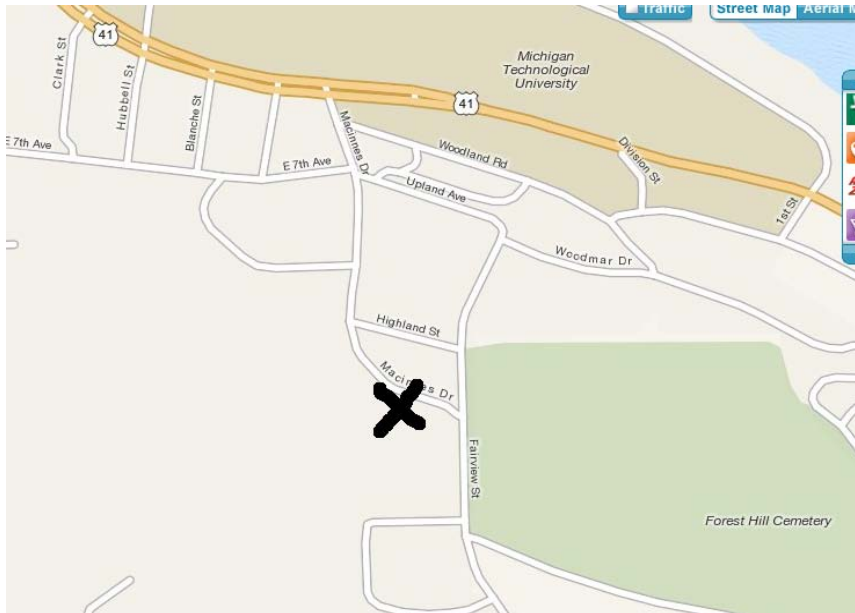
- Winner – Ribbon, Payout – minimum 2 competitors

Directions: Coming in on US 41 South turn left on MacInnes Avenue at the first stop light. Drive up the hill and turn right at the Student Development Complex. Look for the Portage Medical Center entrance and park in the medical center parking lot. Once inside the SDC go up the stairs and follow the signs for the rifle range. You will need to go down a set of stairs to check in for the match. Once 'checked in' there will be a door leading to the parking lot for access to the range.
